Invite interested bidders to participate in the tender for the procurement of the Construction of City Park project from Orma Garage to Afincho – Ber at Addis Ababa..

Floating Date: 45(Forty five) days from the first date of the bid posted on the Newspaper.

Closing Date: 45th working day start from the first date of the bid posted on the newspaper.

1. Addis Ababa Rivers, Riversides Development and Climate Change Adaptation Project Office (ARRDCAPO) invites all interested and eligible bidders by this International Competitive Bid (ICB) for the procurement of the Construction of City Park project from Orma Garage to Afincho – Ber at Addis Ababa. The River Training and Riverside park development extends for 4.4km and covers an area of 12.8 hectare of a river stretch with Bid No. RRSDP/014/2010 to a contract agreement with the finally awarded bidder (s).
2. The Addis Ababa City Government Rivers and Riverside Development and Climate change adaptation Project office now invites suitably qualified bidders Of General Contractor Category-1 (GC -1) with reputable experience in similar nature of works to submit their bid for Construction works of Rivers and Riverside Park Development Project from Orma Garage to Afincho Ber at Addis Ababa
3. Bid documents can be obtained from Addis Ababa Rivers, Riversides Development and Climate Change Adaptation Project Office, Room No. 3 during working hours up on payment of a non-refundable fee of Birr 200.00 (Birr Two Hundred only).
4. All interested bidders are expected to fulfill the Requirements stated here below:
 - a) Bid Security;
 - b) Bidders should have a valid and renewed trade license for the year.
 - c) Bidders should have VAT registration certificate.
 - d) Anti-bribery pledge form

- e) Bidders should have a relevant professional license valid for current working year.
5. The Bid shall be valid for a period of 120 days after bid opening and must be accompanied by a bid security in the amount of Birr 500,000.00 (Birr Five Hundred Thousand only)
- 5.1. The bid bond shall be furnished in one of the following forms:-
- a) Certified Cheque /CPO issued by a recognized domestic bank or
 - b) Bond issued by and/or confirmed through a recognized/reputable domestic bank.
 - c) Cash Deposit Advise
- 5.2. The Bank that issues the bond as per 6.1 (b) here above shall unequivocally guarantee to pay the purchaser immediately upon the first written demand of payment. The Purchaser's written demand of payment shall not be subject to any condition whatsoever.
- 5.3. The bond issuing bank shall clearly incorporate the content stated under Clause here above on the issued bond.
- 5.4. The security shall be valid for twenty eight days (28) beyond the end of the validity period of the bid.
- 5.5. Sealed bids marked as: "Tender for the the Construction of City Park project from Orma Garage to Afincho – Ber at Addis Ababa. The River and Riverside park development extends for 4.4km and covers an area of 12.8 hectare of a river stretch with Bid No. RRS DP/014/2010 and be addressed to: Addis Ababa Rivers, Riversides Development and Climate Change Adaptation Project Office. Bid proposal will be received at the Addis Ababa Rivers, Riversides Development and Climate Change Adaptation Project Office, at 4th floor Room No 3on or before 2:00 pm (afternoon) of 45th working day start from the first date of the bid posted on the newspaper. The working day of AARRDCCAPO Monday to Friday 8:30 to 5:30. Bids presented by any bidder after the closing date shall not be accepted.
6. Bids received in time and fulfilling the other formalities shall be opened in the presence of interested bidders or their legal representatives on the same day (45th day) at 2:30 pm at Addis Ababa Rivers, Riversides Development and Climate Change Adaptation Project Office, Gurd shoal street, 200m from Ethiopian Athletics federation building, left, New building 4th floor Room No 3.. If the 45th date is not the working date, it will be on the next working day.
7. Partial bid is not allowed.
8. Bidders are seriously advised to read and comply with the instructions provided in the bidding document.
9. No one is allowed to duplicate or transfer the bidding document that she/he acquired to participate under this invitation. Legally authorized agents shall collect the bidding documents for each principal they are representing.

10. Bidding will be conducted in accordance with open national tender procedures containing in the public procurement proclamation of the government of the federal democratic republic of Ethiopia and is open to all bidders from eligible source countries.
11. All payment modalities for project execution shall be in local currency,i.e Ethiopian Birr(ETB)
12. All eligibility certificates should be found in the original technical document envelope and are submitted in the tender box on or before the closing date.
13. The winner supplier shall furnish 10% of the contract price amount as performance guarantee with in 15 days as of the contract signing date.
14. Addis Ababa Rivers, Riversides Development and Climate Change Adaptation Project Office reserve the right to reject all or parts of this bid.
